Ms. Gomez,

We will be canceling Claire's appointment scheduled for September 10, 2008 at 12p. Twenty months ago we asked for therapy. Mr. White refused. Now that a "MOTION FOR TESTIMONY & ATTENDANCE OF MINOR CHILD" is filed with the court, Mr. White agrees to therapy. Your records are locked up and that is another delay for Mr. White. Last year when Jud Boyd made arrangements without Mr. White's permission for Claire to be evaluated for therapy at CAC, why did this not settle the issue of parental alienation that he is claiming? He has bullied his way with everyone involved in this case and everyone is afraid of him....ie: Several DCF/CAC caseworkers, Arcadia Center, the clerks at the courthouse and even Judges #1-7 [yes we are on judge #8]. This is the 3rd false report with DCF by Mr. White, when he has ABANDONED Claire.....not been alienated. No contact from Oct. 24, 2007 (last court date with Judge LaPorte) until court date of June 6th, 2008 (with Judge Brace) and only because I brought her with me to court. Since June 6th he has called.....(not written or offered financial support for three years)...once in July and August..when she answers the phone and tells him she "does not want to talk and don't call back". He says that I am alienating her from him when he has ABANDONED her. Ask Mr. White who spent 6 hours cleaning Claire's room in his apartment, who brought over a computer and desk, chair, bookcases, toy box with things, tv, vac, snacks and personal grooming items. Does this sound like someone who is trying to keep distance between a parental relationship? Claire is very aware that she can visit or talk to her father at anytime. It is her decision not to have contact. If you continue to allow Mr. White to "abuse the system" (as you stated to my husband on Christmas Eve when we met in your Niceville office) I have no choice but to file a law suit against DCF/CAC for harassment.

However, Mr. White's sincerity in finally allowing therapy after 20 months is doubtful and we will wait for the next judge to order the psychologist. Considering Mr. White's past and recent displays of aggression he can not be trusted. My husband provides health coverage for Claire and we will choose a private physician. Why is Mr. White now allowing therapy when she needed it 20 months ago after he drove around like a mad man with her in his car for 6 hours instead of returning her as promised on that Sunday afternoon while I waited in his driveway?

We will not be needing your services as they have proven to be unbeneficial toward resolving this matter.
